AGENDA ITEMS:

1. **La Jolla Community Parade** – Request for street closures for the La Jolla Community Parade event on December 13th 2015 (San Diego County Diversity and Inclusiveness Group) – Voting Item

Continued to July meeting for additional community outreach by applicant

2. **2015 San Diego Triathlon Challenge** - Request for temporary street closure, lane closure and No Parking related to athletic competition event at Scripps Park on October 18th 2015 (Challenged Athletes Foundation – Voting Item)

Street closures, etc. - Approved – 8-0-0

3. **Speed Limit Decrease** – Proposal to reduce speed limit from 30mph to 25mph on La Jolla Shores Drive from El Paseo Grande to N. Torrey Pines Rd. (from City Staff) – Voting Item

Opposed decrease – 5-3-0 Approved leaving speed at 30mph – 7-0-0 (Warwick)

4. **Additional Traffic Control at Traffic Circle** – The City is contemplating a speed hump or placement of pylons to control diverting traffic at the Via Capri/Senn Way traffic circle – Input for City Staff

Recommend one speed hump on north side of traffic circle and no pylons – unanimous

5. **Nomination of Officers** – Nominations from the floor for positions of Chairperson, Vice-Chairperson and Secretary. Election of Officers to take place at the next Regular meeting in July.

Candidates nominated – election at July meeting

- 6. Proposal to Eliminate Parking** – Concept to eliminate parking on portion of Coast Blvd. and install Class 2 bike lane consistent with the Whale View Point project of the La Jolla Parks & Beaches Committee – Discussion only

Asked proponents to solicit input on proposal from affected residents along Coast Blvd. and come back at July meeting

- 7. Removal of White Curb** – With closure of restaurant at 1205 Prospect Street it no longer qualifies as a Valet Zone and the white curb in front will be removed – Information Item
