A Process 3 Coastal Development Permit and Site Development Permit to convert the existing grade level storage area of a 5-story multifamily building into a residential unit with a new elevator and access from the basement, located at 7460 Olivetas Avenue, also known as Assessor's Parcel number 350-570-1800. The 1.55-acre site is in the La Jolla Planned District (LJPD-5) Zone, Coastal Height Limit Overlay Zone, Coastal (Appealable) Overlay Zone, Coastal Overlay Zone First Public Roadway, Transit Priority Area, a High Paleontological Sensitivity area, within the La Jolla Community Plan Area. Council District 1. This development is within the Coastal Overlay zone (Appealable), and the application was filed on February 19, 2026.
